**RESOLUTION BY THE FINANCE AND BUDGETARY COMMITTEE
SETTING FORTH THE FEES
IN CONNECTION WITH CHAPTER 11 OF THE CODE OF ORDINANCES
RELATING TO ENVIRONMENTAL SANITATION**
