**RESOLUTION BY THE PUBLIC WORKS AND CAPITAL
IMPROVEMENTS COMMITTEE AUTHORIZING THE VILLAGE TO
CONSTRUCT CERTAIN SIDEWALKS WITHIN THE VILLAGE IN THE
MAJESTIC HILLS SUBDIVISION**

WHEREAS, the Village of Sturtevant finds that there is a necessity to install certain sidewalks at the land owners expense in order to establish a safe and continuous negotiable way for pedestrian traffic at certain locations in the Village; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

1. That pursuant to Section 8.01 (12) of the Municipal Code authorizes the Sturtevant Public Works Department to construct and install on its own or through the use of an outside contractor the sidewalk at the locations in the Village of Sturtevant set forth in Exhibit A which is attached hereto and incorporated herein.
2. That the Sturtevant Public Works Department shall first use any posted sidewalk bond money for said installation and if any available bond money does not cover the costs, shall submit a bill to the owner of the parcel for said installation and if said bill is not paid within 30 days the amount due shall be assessed against the property as authorized by Section 8.01 (12).
