### NOTICE OF OPEN HOUSE/PUBLIC HEARING

Please take notice that a joint Open House/Public Hearing meeting will be held by the Village Board of the Village of Sturtevant on Tuesday, June 2, 2009 at 5:00 p.m. at the Village Hall, 2801 - 89th Street, Room A, at which time the Village of Sturtevant Planning Commission will consider recommending that the Village Board adopt the Multi-Jurisdictional Comprehensive Plan for Racine County as the comprehensive plan for the Village. The open house will be held from 5:00 to 6:00 p.m., followed by a public hearing at 6:00 p.m.

Adoption of the plan follows several years of work by the Village, in cooperation with Racine County, UW-Extension, and SEWRPC. The plan addresses the nine elements and includes a series of maps, goals, objectives, policies, and programs to guide development to the year 2035, in accordance with the requirements of Section 66.1001 of the Wisconsin Statutes. The Village Board will enact an ordinance to formally adopt the plan.

Copies of the Multi-Jurisdictional Comprehensive Plan for Racine County will be available for review prior to the Open House/Public Hearing at Village Hall during the hours of 8:00 a.m. to 5:00 p.m. most Mondays through Fridays, at the Racine Public Library at 75 7<sup>th</sup> Street in Racine, or on-line at <http://racine.uwex.edu/cnred/SmartGrowth.html>. Written comments will be accepted through June 2, 2009 at 5:00 p.m. Any questions, written comments, or requests for copies of the plan should be directed to Village Clerk Mary Hanstad at 2801 - 89th Street, Sturtevant, WI 53177. Written comments will be addressed at the public hearing and will be given the same weight as oral testimony.

The purpose of this hearing is to hear public opinion on the Multi-Jurisdictional Comprehensive Plan for Racine County described above.
