



is an affordable and fun transportation service designed primarily for active Racine County seniors, making it convenient to get to your appointments, needed services, volunteer opportunities, and special events in your community, or just to go shopping or visiting with your friends and family. The general public is also welcome to ride **SPARC** on a space available basis.

### ROUTES

**SPARC** operates three scheduled routes each week:

- **Burlington**

Monday thru Friday - 9am to 3pm  
This route alternates northbound and southbound through City of Burlington from Pine St. to WalMart.

- **Waterford**

Wednesdays - 9am to 3pm  
This route covers Waterford with service to WalMart.

- **Mt.Pleasant/Sturtevant**

Monday, Tuesday, Friday & Saturday - 9am to 3pm.  
This route alternates eastbound and westbound along Hwy 20, Hwy 31 and Hwy 11.

(Schedules are shown inside this brochure. **All times are approximate** as SPARC is subject to traffic, construction and weather.)

### BOARDING

You may board at any of the designated timed stops. The service is flexible and may permit other nearby stops along these general routes. Simply tell the driver where you'd like to go.

You may always call **(262) 676-1630** if you have any questions about where, when, or how to catch **SPARC**.

### FARES

- **\$2.00** for a point to point trip
- **\$3.00** for a round trip that allows you to board twice in one day
- **\$5.00** for a day pass that allows unlimited use in one day

Discounted multiple ride passes are also available on board from the driver.

### PLEASE NOTE

**SPARC** is not in service on the following six holidays: New Year's Day, Memorial Day, July 4<sup>th</sup>, Labor Day, Thanksgiving Day and Christmas Day.

**SPARC** is made possible with funding from Racine County and SPARC is operated by Kenson Enterprises, LLC.

Although SPARC is not equipped to accommodate mobility devices other than collapsible walkers, other transportation options for seniors and adults with disabilities are available.
