**RESOLUTION BY THE ECONOMIC DEVELOPMENT AND REDEVELOPMENT COMMITTEE ENDORSING AN AMENDMENT TO THE NATURAL AREAS AND CRITICAL SPECIES HABITAT PROTECTION AND MANAGEMENT PLAN FOR THE SOUTHEASTERN WISCONSIN REGION**

WHEREAS, the Southeastern Wisconsin Regional Planning Commission, which was duly created by the Governor of the State of Wisconsin in accordance with Section 66.0309(2) of the *Wisconsin Statutes* on the 8<sup>th</sup> day of August 1960, upon petition of the Counties of Kenosha, Milwaukee, Ozaukee, Racine, Walworth, Washington, and Waukesha, has the function and duty of making and adopting a master plan for the physical development of the Southeastern Wisconsin Regional; and

WHEREAS, the Southeastern Wisconsin Regional Planning Commission adopted on December 1, 2010 a natural areas and critical species habitat protection and management plan for the development of the region which was set forth in a report entitled *Amendment to Natural Areas and Critical Species Habitat Protection and Management Plan for Southeastern Wisconsin Region*, and

WHEREAS, the Commission has transmitted certified copies of its resolution adopting *Amendment to Natural Areas and Critical Species Habitat Protection and Management Plan for Southeastern Wisconsin Region* to the local units of government of the Southeastern Wisconsin Region: and

WHEREAS, the Village of Sturtevant believes that the *Amendment to Natural Areas and Critical Species Habitat Protection and Management Plan for Southeastern Wisconsin Region* prepared by the Commission will be a valuable guide not only to the development of the Region but of the Village of Sturtevant as well, and that the endorsement of such plan by the Sturtevant Board of Trustees will assure a common understanding by the several governmental levels and agencies concerned and enable their staffs to program the necessary areawide and local plan implementation work.

NOW THEREFORE, BE IT RESOLVED that the Village Board of the Village of Sturtevant Trustees hereby endorses *Amendment to Natural Areas and Critical Species Habitat Protection and Management Plan for Southeastern Wisconsin Region* as a guide for regional and community development.

BE IT FURTHER HEREBY RESOLVED that the Village clerk transmit a certified copy of this Resolution to the Southeastern Wisconsin Regional Planning Commission
