**RESOLUTION BY THE ADMINISTRATION, PERSONNEL, POLICY AND
LEGAL COMMITTEE AUTHORIZING SALARY ADJUSTMENTS EFFECTIVE
JANUARY 1, 2015 AND JULY 1, 2015 FOR CERTAIN NON-REPRESENTED
EMPLOYEES**

WHEREAS, the Village Board authorized collective bargaining contract with the Sturtevant Professional Police Association that provide certain pay adjustments for union employees in 2015;

WHEREAS, the Village Board believes that pay adjustments are appropriate for certain non- represented employees.

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

1. That the following full time non represented employees shall be granted a 1% pay increase effective January 1, 2015 and a 1% pay increase effective July 1, 2015: Village Administrator/ Clerk/Treasurer, Police Chief, Deputy Clerk/Records/Network Administrator, and Accounting Clerk.
2. That the Police Department Records Clerks will receive a wage increase from \$13.50 to \$14.00 per hour
3. That the actual pay rates are set forth in Exhibit A which is attached hereto and incorporated herein.
4. That the costs for said wage adjustments were included in the 2015 Budget
