**RESOLUTION AUTHORIZING A CONTRACT WITH WORLDPAY, LLC
AND GOVERNMENT PAYMENT SERVICES (d/b/a "GovPayNet") TO
PROVIDE CREDIT CARD AND DEBIT CARD PROCESSING SERVICES FOR
THE VILLAGE OF STURTEVANT**

WHEREAS, Government Payment Service (GPS) provides GovPayNet Payment Network, consisting of governmental entities that have each contracted with GPS to accept payments on their behalf made using credit cards and debit cards by their authorized users for transmission to such entities and the Village in order to improve the Village's services and enhance administration, desires to accept payments through GPS with related support services as GPS provides ; and



WHEREAS, the Village continually strives to increase our service to our customers and they currently do not have the ability to pay their bills on line or via credit cards or debit cards at the Village Hall and there is a credit card acceptance service at the Police department for tickets but that service costs the Village money to provide the service; and

WHEREAS, this service by GPS or GovPayNet, is a service that passes the convenience fee on to the customer and not absorbed by the Village and the customers will also be able to pay online via the website and convenience terminals will be provided at the Village hall and the Police Department; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby authorize the Village Administrator to sign a contract with Worldpay, LLC and Government Payment Services (d/b/a "GovPayNet") to provide credit card and debit card processing services for the Village of Sturtevant.
