WHEREAS, Racine County has undertaken an initiative to provide and expand internet access to all of Racine County; and



WHEREAS, Racine County, through though careful research and consideration has identified that internet access is a key community need and foundational to accessing critical supports and services; and

WHEREAS, the Village participate in this Racine County endeavor and support the provision of internet service through use of our Village Hall facility for the installation of equipment in and on the building; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

The Village of Sturtevant will provide the Village Hall facility to mount equipment on the north side wall near the northeast corner of the building (small dish and associated electrical and low voltage conduit) and a small space in the electrical room for the internet box and that the Village President and Village Clerk shall be authorized to sign any and all documents associated with this program between Racine County and E-vergent (internet provider for the Racine County), all at no cost to the Village of Sturtevant.

**RESOLUTION BY THE VILLAGE BOARD OF THE VILLAGE OF STURTEVANT
AUTHORIZING PERSONNEL CHANGES FOR THE DEPARTMENT OF PUBLIC
WORKS**

WHEREAS, THE Village of Sturtevant recognizes the need to provide core services to the customers in the Village; and

WHEREAS, the Village of Sturtevant understands that there has been a supervisory level vacancy in the Public Works Department since July 17, 2020 and that there is a need to have back-up snow plow operators for the snow season to provide back-up and or relief for the current staff and that summer part time help for grass mowing and like duties would allow for fulltime staff to provide needed summer project completion and to perform additional responsibilities; and

WHEREAS, the Village of Sturtevant, currently operates with only 4 Department of Public Works personnel to accomplish all required responsibilities and other staff to oversee and or perform responsibilities; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

The Village of Sturtevant will advertise for a Public Works Department Supervisory position to seek candidates for the vacant supervisory position, seek reliable and qualified candidates for on-call relief /back-up snow plow operators for the snow season, and seek reliable and qualified candidates for part-time summer grass mowing and like duties during the grass mowing season (typically May through October)
