WHEREAS, According to Section 98.04 (2), Wis. Stats., the Village of Sturtevant may recover an amount not to exceed the cost of fees for weights and measures inspection work by assessing fees on the persons who receive the services rendered; and

WHEREAS, the Village Fees for weights and measures services provided are \$20.00 each small capacity scale, meter or liquid measuring device (LMD) and shall be billed by the Village during the annual license renewal period; and


WHEREAS, that the schedule of fees, permits and charges may be amended from time to time by resolution of the Village Board.
