WHEREAS, at this time the Village would like to proceed with the Dog Park Fence upgrades.


NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

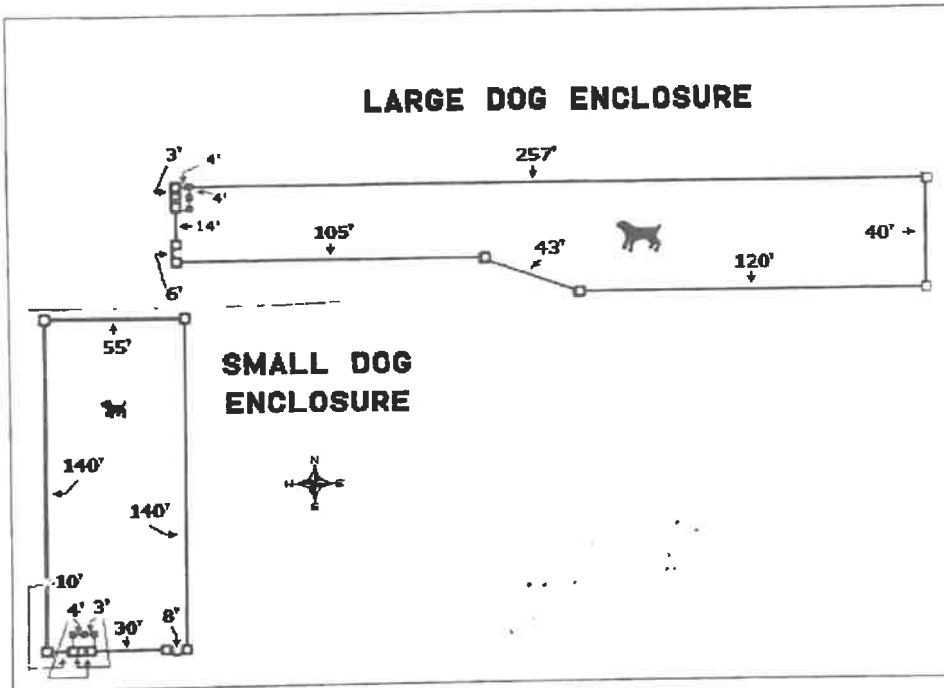

If property pins cannot be located, it is recommended that the customer have the property surveyed.

CUSTOMER IS RESPONSIBLE FOR LOT LINES, DIRT REMOVAL, & PERMITS.

STATEWIDE FENCING, INC. will assume the responsibility for having underground public utilities located and marked. However, STATEWIDE FENCING, INC. assumes no responsibility for unmarked sprinkler lines or any other buried lines or objects. The customer will assume all liability for any damage caused by directing STATEWIDE FENCING, INC. to dig in the immediate vicinity of known utilities.

A finance charge of 1.5% per month (or a minimum of \$1.00), which is an annual percentage rate of 18%, shall be applied to accounts that are not paid within 10 days of completion of work. All materials will remain the property of STATEWIDE FENCING, INC. until money owed is PAID IN FULL. Right of access and removal is granted to STATEWIDE FENCING, INC. in the event of non-payment under the terms of this contract. The customer agrees to pay all interest and costs incurred in the collection of this debt.
