RESOLUTION BY THE FINANCE AND BUDGETARY COMMITTEE REVISING THE FEES FOR EMERGENCY SERVICES PURSUANT TO SECTION 5.11 OF THE CODE OF ORDINANCES FOR THE VILLAGE OF STURTEVANT ENTITLED "FEES FOR EMERGENCY SERVICES"

The Village Board of the Village of Sturtevant, Racine County, Wisconsin, resolves as follows:

## **RECITALS**

- 1. Section 5.11 of the Code of Ordinances for the Village of Sturtevant requires payment of fees for Emergency Services including, but not limited to, Schedule of fees for service, transfer service used in ALS and BLS services, and charges for fire calls on highway, as set forth on an itemized schedule of fees to be determined and revised, from time-to-time, by resolution of the Village Board.
- 2. After consideration of the prior schedule of fees, the Village Board is prepared to approve an updated schedule with fees similar to those utilized by other communities in Southeastern Wisconsin and to those approved by the Fire/EMS oversight committee and the Village of Mt. Pleasant.

NOW THEREFORE, BE IT RESOLVED that the attached schedule of fees, Exhibit A, dated September 14, 2021 be, and hereby is, adopted.
