## RESOLUTION BY THE ADMINISTRATION, PERSONNEL, POLICY & LEGAL COMMITTEE OF THE VILLAGE OF STURTEVANT AUTHORIZING A CONTRACT WITH THE LEAGUE OF WISCONSIN MUNICIPALITIES MUTUAL INSURANCE AND THE MUNICIPAL PROPERTY INSURANCE COMPANY FOR THE YEAR 2023

WHEREAS, there is a need to obtain commercial insurance and property insurance for the Village for 2023; and;

WHEREAS, it would be in the best interests of the Village to continue commercial insurance coverage and Cyber Insurance coverage with the League of Wisconsin Municipalities Mutual Insurance for 2023; and

WHEREAS, it would be in the best interests of the Village to continue property insurance coverage with the Municipal Property Insurance Company for 2023; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

- 1. That the execution of an agreement with the League of Wisconsin Municipalities Mutual Insurance for certain commercial insurance coverage and Cyber insurance and the Municipal Property Insurance Company for property insurance for the village for the year 2023 is authorized and approved subject to final review by the Village Administrator.
- 2. That the annual premium and the coverage for said commercial insurance, property insurance and cyber insurance is set forth in Exhibit A which is attached hereto and incorporated herein.
- 3. That the Village Administrator is authorized to make minor adjustments in the deductibles, coverages and the premium provided that the cost remains within the budgeted amount for commercial insurance within the 2023 budget.
- 4. That the Village of Sturtevant is authorized to participate in the League of Wisconsin Municipalities Mutual Insurance and the Municipal Property Insurance Company for the purpose of obtaining said coverage.
- 5. The Village President and the Village Clerk are authorized to sign any agreements or other documents necessary to carry out the intent of this resolution.

## Hi Amanda,

I'm pleased to present your 23-24 Village of Sturtevant Renewal Proposal from the League of Wisconsin Municipalities Mutual Insurance Program (LWMMI), the Municipal Property Insurance Company (MPIC) and our partner carriers that include Hanover and United Heartland. The numbers came in with an overall total package of premiums decrease of -0.9%.

I would direct your attention to pages 3-5 of the Proposal which are the comparison pages. This is a perfect quick glance at any changes from last year to this year. The LWMMI is continuing to realign some of the pricing credits on accounts to better match up with their actuarial suggested rates. This will help them properly price accounts based on their different exposures and claim experience. You will notice the total package of premiums for the LWMMI only went up by 0.3% overall. Unfortunately, the MPIC Property Insurance Premium increase is due to an across the board increase on Property rates all over the country. Cost of building materials and supply chain issues have caused this major uptick in Property premiums and there is an inflation factor on the values to increase automatically, so the combination of this caused the 12.3% increase. The Workers Comp premium only went up by 0.5% and this is mainly due to the increase in payrolls because the rates did go down as well as your mod. Again an overall decrease of -0.9% for a Total Estimated Package of Premiums of \$128,423.

Lastly, the Cyber Insurance. The LWMMI came in with an excellent quote of \$2,383 for a decrease from Chubb of -58.0%. If we stayed with Chubb the premium would have went up by 103.3%. It is my recommendation to go with the LWMMI for the Cyber coverage. (please see pages 26-30 which are the two quotes)

Please let me know if you would like to set up a meeting to review all of this information. I'd be more than happy to come out. I look forward to hearing from you either way and I hope you have a great weekend and Thanksgiving.
