WHEREAS, at this time the Village would like to proceed with said improvements; and

NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

1. That the awarding of a contract to Payne & Dolan, Inc of Kenosha, Wisconsin, in the amount of \$878,765.79 for the Enterprise Way Expansion Project, and, is hereby authorized and approved.
2. That the following projects for the Enterprise Way Expansion Project work is to be completed in 2023 using funds from the Capital Projects Fund 405 That the funds for said contract and said project shall be taken from Account 405-57331-820.
3. That the total costs for the project shall not exceed \$880,000.00 which includes engineering, legal and administration and contingencies.
