AMENDMENT TO RESOLUTION NO. 2022-18 PURCHASE OF TRAIN DEPOT
SECURITY CAMERAS WITH FUNDS RECEIVED FROM THE AMERICAN
RESCUE PLAN ACT**

WHEREAS, THE Village Board approved the Purchase of Train Depot Security Cameras with funds received from the American Rescue Plan Act per Resolution 2022-18; and

WHEREAS, there is a need for a Falcon Law enforcement grade infrastructure-free license plate recognition camera with Vehicle Fingerprint technology at the Sturtevant Depot; and

WHEREAS, there are sufficient funds in 225-58200-690 within the ARPA Funds to purchase this equipment; and


WHEREAS, flock safety has provided a quote of approximately \$2,850.00 for the Falcon Law enforcement grade infrastructure-free license plate recognition camera with Vehicle Fingerprint technology.


NOW THEREFORE, the Village Board of the Village of Sturtevant, Racine County, Wisconsin does hereby resolve:

1. The purchase of Falcon Law enforcement grade infrastructure-free license plate recognition camera with Vehicle Fingerprint technology from flock safety at a cost not to exceed \$8,000.00.
2. That the funds for said purchase shall be taken from Fund 225-58200-690 within the ARPA Funds.
3. That the Village President and the Village Clerk are authorized to execute contracts, agreements or other documents necessary to carry out the intent of this resolution.
