FREQUENTLY ASKED QUESTIONS

- 1. If my mailing address is "Racine" but I reside WEST of I-94, may I participate in the Racine Wastewater Utility's HHW collection? No. Residents west of I-94 do not fund this program. Only those within our service area may participate. If you reside in Burlington, Union Grove, Dover OR Waterford please call the Burlington Wastewater Utility at (262) 342-1181. All others please contact your village/town hall to inquire about Clean Sweep/HHW collections available to you.
- **2.** How do I dispose of latex (water-based) paint? Use paint hardener, oil dry or kitty litter to dry the paint. City of Racine residents must bring their dried paint cans to the Pearl Street Waste Site. Others may throw dried paint cans in the trash or contact their solid waste collector for instruction.
- **3. Where can I dispose of medications &/or sharps?** Call the City of Racine Health Department at 262-636-9203 or visit https://cityofracine.org/Environmental-Health/ for drop box locations.
- **4. How do I dispose of items NOT accepted at the HHW collection?** Contact your village/town hall for recycling & disposal options. You can also contact area junk removal companies, local scrap yards, etc. for assistance.
